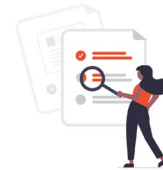

## THE STEPS INVOLVED IN CARRYING OUT A SME'S CARBON FOOTPRINT

---

### Step 1

---

**Meeting with the client** to determine the information that will be necessary for the realization of the carbon footprint. The building will be considered as the **calculation perimeter**.

### Step 2

---

**Collection of data and information** to quantify direct emissions (**scope 1**), indirect emissions (**scope 2**) and other indirect emissions (**scope 3**) such as transport of people and goods and waste. The SME must provide the supporting documents required to calculate its carbon footprint.

### Step 3

---

**Calculation of the carbon footprint** according to the period determined in step 1 and in accordance with the requirements of the International **Standard ISO 14064-1:2018**.

### Step 4

---

**Creation and delivery of a carbon footprint report** with an **opportunity plan** for reduction projects and **tailored recommendations**. This includes recommendations on clean technologies, but also on eco-responsible behavior. The opportunity plan also includes the identification and qualification of GHG reduction projects that can be applied to the building.
