	Issue Section 2.4 of the Verification Report has not provided enough information on the facilities which were visited during the site visit. Action item 1. The VVB must ensure that they provide information on which facilities were visited during the onsite audit in the current monitoring period. Program Rule(s) VCS Verification Report Template v.4.3, Section 2.4	Round 1 VVB Response The facility IDs(CF 1602, 1603 and 1604) were already mentioned under section 2.3 of the verification report. It has been also included under Section 2.4 of the verification report specifying the old and new ones. It shall be noted that project proponent has clearly stated under Appendix 1- 'Commercially sensitive information' of the MR that the Client Facility names are anonymized and replaced by Client Facility ID numbers. Confidential version of ER sheet titled 'ID929-Annex B-MP7-Confidential-(2022)-2024-v2.1.xlsx' mentions the details of facility in tab 'ER 2022 scope 3 and 13'. We request VERRA to and consider linking the IDs mentioned in the verification report with the above sheet referred as the client information is commercially sensitive.
